WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the G-EPS and PAGASA Bulletin board continuously for 7 days from **18 July to 24 July 2019**, the procurement of the following civil works described hereunder, with its corresponding Approved Budget for the Contract (ABC), under the reference, **P.R. No. 2018-12-1923/ IB No. 2019-003**, to wit:

- c) to **RECOMMEND**, finally, the **APPROVAL** of aforementioned finding and recommendations.
