WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the G-EPS and PAGASA Bulletin board continuously for 7 days from 18Julyto 25July 2019, the procurement of the following civil works described hereunder, with its corresponding Approved Budget for the Contract (ABC), under the reference, P.R. No. 2018-12-1924/ IB No. 2019-004, to wit:

WHEREAS, the provision of R.A. 9184 and its revised Implementing Rules and regulations (IRR), other pertinent guidelines and procedures relative to government procurement system are hereby observed and strictly implemented for the whole duration of this bidding activity;

WHEREAS, two (2) prospective bidders namely: 1) JHAK Construction, and 2) FFJJ Construction expressed their intention to participate. However, on **09 August 2019** only JHAK Construction attended the Pre-Bid Conference conducted by the PAGASA-BAC.

WHEREAS, on 22 August 2019 the schedule for Submission and Opening of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), only FFJJ Construction participated. The representative from FFJJ Construction expressed to the BAC members that their bidding documents were still in transit. Unfortunately, FFJJ Construction's bidding documents did not reach. on time as schedule, hence, PAGASA-BAC members did not accept the submission thereof;
