Opening of sealed bids shall immediately follow thereafter in the presence of the bidder's representative who opted to attend.

E. Sealed bids should be accompanied by a refundable Bid Security in the form of cash or cashiers/managers check equivalent to ten percent (10%) of the total amount of the bidders offer, the Bid Security shall constitute as the initial payment for the unserviceable property/equipment.

Bidders shall bid on all items. Only bids equal to or higher than the above minimum bid price shall be accepted.
