



**BAC Resolution Declaring 2nd Failure of Bidding;
and Recommending Approval**

Resolution No. 2018-024

WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the G-EPS and PAGASA Bulletin board continuously for 7 days from **25 to 31 July 2018 and in the newspaper of nationwide circulation on 25 July 2018, the Re-bidding** for the procurement of the following goods/items described hereunder, with its corresponding Approved Budget for Contract (ABC), under the reference, **PR# 2018-04-0262 and IB# 2018-010**, to wit:

WHEREAS, in response to the said advertisement, **only one (1) bidder, PLDT Enterprise**, expressed its respective intentions to participate in the bidding of the above Project, and attended the **Pre-Bid Conference** conducted by the PAGASA-BAC on **02 August 2018**.

WHEREAS, all noted deviations and/or amendments attendant to the Project as discussed and agreed upon in the above mentioned meeting was issued through a **Supplemental Bid/Bulletin (SBB) with reference Addendum No. 2018-010-01 dated 07 August 2018**; and herein made part of this Resolution as Annex "A";

WHEREAS, on **14 August 2018**, the schedule for **Submission and Opening** of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), PLDT Enterprise timely submitted its bid tender for the Project; however, the BAC declared a Failure of Bidding due to the missing required documents under the list of on-going projects and not using the PAGASA BAC prescribed form under the Manufacturer's Authorization;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- to **DECLARE**, a **2nd Failure of Bidding** for the above-entitled Project;
- to **RECOMMEND** the mandatory review and evaluation of terms, conditions and specifications of the project pursuant to Section 35 of the IRR of RA 9184;
- to **RECOMMEND**, further that resort to the alternative method of procurement, through **Negotiated Procurement** pursuant to Section 53 (1) in relation with Section 35 of the IRR of RA 9184; and
- to **RECOMMEND**, finally, the **APPROVAL** of aforementioned finding and recommendations.
