**WHEREAS**, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the G-EPS and PAGASA Bulletin board continuously for 7 days from **20 to 27 November 2019** the Re-Bid of the Procurement of the following good/item described hereunder, with its corresponding Approved Budget for the Contract (ABC), under the reference, **P.R. No. 2019-08-0617/ I.B. No. 2019-045**, to wit:

1. to **DECLARE**, the **2<sup>nd</sup> Failure of Bidding** for the above-entitled Project;
2. to **RECOMMEND** the mandatory review and evaluation of terms, conditions and specifications of the project pursuant to **Section 35** of the IRR of R.A. 9184;
3. to **RECOMMEND**, further that resort to the alternative method of procurement, through **Negotiated Procurement** pursuant to Section 53 (1) in relation with Section 35 of the IRR of RA 9184; and
4. to **RECOMMEND**, finally, the **APPROVAL** of aforementioned finding and recommendations.
