**Resolution Declaring 2nd Failure of Bidding;
and Recommending Approval**

Resolution No. 2019-096

WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the G-EPS and PAGASA Bulletin board continuously for 7 days from **08 to 15 October 2019** the Re-Bid of the Procurement of the following civil works described hereunder, with its corresponding Approved Budget for the Contract (ABC), under the reference, **P.R. No. 2018-12-1924/ IB No. 2019-016INF**, to wit:

WHEREAS, the provision of R.A. 9184 and its revised Implementing Rules and regulations (IRR), other pertinent guidelines and procedures relative to government procurement system are hereby observed and strictly implemented for the whole duration of this bidding activity;

WHEREAS, in response to the said invitation, three (3) prospective bidders namely; 1) Sun Rays Builders; 2) KA Builders and 3) HD Engineers & Builders, expressed their intention to participate in the bidding of the aforesaid project but only HD Engineers & Builders did not attend the **Pre-Bid Conference** scheduled by the BAC on **16 October 2019**;

WHEREAS, on **21 October 2019**, the **schedule for submission and opening** of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), the **two (2) participating bidders** namely: **1) Sun Rays Builders** and **2) HD Engineers & Builders**, timely submitted their bid tenders for the project but did not pass the preliminary examination of bids due to non compliant in using the prescribed bidding forms in all the documents submitted. Thus, the PAGASA-BAC declared the Sun Rays Builders and HD Engineers & Builders as disqualified bidder.

NOW, THEREFORE, We, the Members of the PAGASA Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

1. to **DECLARE**, the **2nd Failure of Bidding** for the above-entitled Project;
2. to **RECOMMEND** the mandatory review and evaluation of terms, conditions and specifications of the project pursuant to **Section 35** of the IRR of R.A. 9184;
3. to **RECOMMEND**, further that resort to the alternative method of procurement, through **Negotiated Procurement** pursuant to Section 53 (1) in relation with Section 35 of the IRR of RA 9184; and
4. to **RECOMMEND**, finally, the **APPROVAL** of aforementioned finding and recommendations.
