

Resolution No. 2020-006

WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee (PAGASA-BAC), advertised the Invitation to Bid (ITB) at the PAGASA website the G-EPS and PAGASA Bulletin board continuously for 7 days from **February 01-08, 2020**, the procurement of the following security services described hereunder, with its corresponding Approved Budget for Contract (ABC), under **PR No. 2019-11-2012**, to wit:

WHEREAS, the provisions of R.A. 9184 and its Revised Implementing Rules and Regulations (IRR), series of 2016, other pertinent guidelines and procedures relative to government procurement system are hereby observed and strictly implemented for the whole duration of this bidding activity;

WHEREAS, in response to the foregoing invitation, **only two (2) prospective bidders**, namely: **(1) the LIFEGUARD ARCHANGELS SECURITY AGENCY CORPORATION (LASAC); and, (2) GRAND MERETUS SECURITY AGENCY, INC.**, expressed their respective intentions to participate in the bidding of the aforesaid Project and attended the Pre-Bid Conference conducted by the PAGASA-BAC on **February 10, 2020**;

WHEREAS, any and all amendments and revisions relative to the specific requirements of the Project, the responses to specific queries of prospective bidders and pertinent Instructions to Bidders have been duly issued and posted as Supplemental/Bid Bulletin (SBB) and hereto attached and made integral part of this Resolution as Annexes "A";

WHEREAS, on **24 February 2020**, the scheduled submission, receipt and opening of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), however, **only LIFEGUARD ARCHANGELS SECURITY AGENCY CORPORATION** timely submitted its bid tender for the Project; and, consequently passed the preliminary examination of bids;

WHEREAS, in the subsequent opening of Envelope No. II (Financial component), **the lone bidder's** financial proposals had been accepted by the PAGASA-BAC having passed the financial requirements of the Project. Its financial proposal, "**as Read**", is summarized as follows:
