## A. Query from **SUPERSERVE CORPORATION**.

Query No.	Particulars	Answers
1.	j. Bidder must have employed and assigned an authorized Safety Officer as member of Safety Organization of the Philippines (SOPI).  We wish to inform that SOPI is just one among the hundred plus Safety Training Organizations (STO) accredited by DOLE in the Philippines. The key function of STOs is the conduct of Safety Training for employers, workers and OSH professionals. We believe having employed and assigned as Authorized Safety Officer as a requirement is plain fair, but to single out an STO in order to be eligible is tantamount to limiting the number of willing participants to the subject project.	In order to relax our Bidder Eligibility Requirement under Section H of the Terms of Reference (TOR), all prospective bidders to be eligible are required to have a Safety Officer who assumed Safety Officer Training for employers, workers and OSH professionals in any training centers which are accredited by the Department of Labor and Employment (DOLE) Philippines and but not limited only to Safety Training Organizations (STO).
	Our Authorized Safety Officer are all graduates of both Basic Occupational Safety and Health (BOSH) and Construction Occupational Safety and Health (COSH) courses and holders of Training Certifications issued by the Department of Labor and Employment (DOLE).  In view of the foregoing, we earnestly pray for the BAC's preferential attention and review of item Junder Section H of the tender documents.	

This shall form an integral part of the Bid Documents.
