WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the G-EPS and PAGASA Bulletin board continuously for 7 days from **27 September to 18 October 2019**, the procurement of the civil works with its corresponding Approved Budget for the Contract (ABC), under the reference, **P.R. No. 2019-05-0409/ IB No. 2019-012INF**, to wit:
