



PAGASA BIDS AND AWARDS COMMITTEE (PBAC)

**Resolution Declaring 2nd Failure of Bidding;
and Recommending Approval**

Resolution No. 2021-053

WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the G-EPS and PAGASA Bulletin board continuously for 7 days from **26 October to 02 November 2021** the procurement of the following goods/items described hereunder, with its corresponding Approved Budget for the Contract (ABC), under **PR No. 2021-05-0317 and ITB 2021-047**, to wit:

WHEREAS, the provision of R.A. 9184 and its Revised Implementing Rules and Regulations (IRR), other pertinent guidelines and procedures relative to government procurement system are hereby observed and strictly implemented for the whole duration of this bidding activity;

WHEREAS, in response to the said invitation, only **Gentec Distribution Corporation** expressed its intention to participate in the bidding of the aforesaid Project, and attended the **Pre-Bid Conference** conducted by the PAGASA-BAC on **03 November 2021**;

WHEREAS, all noted deviations and/or amendments including the BAC's answer and the clarificatory letter/s submitted by the prospective bidder attendant to the Project as discussed and agreed upon in the above-mentioned meeting was issued through a **Supplemental Bid/Bulletin (SBB)** with reference to **Addendum No. 2021-047-01** dated **08 November 2021** herein made part of this Resolution as Annex "A";

WHEREAS, on **15 November 2021**, the **schedule for submission and opening** of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), only **Joint Venture of Gentec Distribution Corporation and Kirsters AG** timely submitted their bid tenders for the project and passed the preliminary examination of bids.

WHEREAS, upon careful examination, validation and verification of **Joint Venture of Gentec Distribution Corporation and Kirsters AG** tender documents the PAGASA-BAC determined that, **Joint Venture of Gentec Distribution Corporation and Kirsters AG** declared as "Disqualified" due to failure to comply with the simple instructions to bidders more specifically, failure to submit updated tax clearance.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) to **DECLARE**, the **2nd Failure of Bidding** for the above-entitled Project;
- b) to **RECOMMEND** the mandatory review and evaluation of terms, conditions and specifications of the project pursuant to Section 35 of the IRR of RA 9184;
- c) to **RECOMMEND**, further the resort to the **Alternative Method of Procurement**, through **Negotiated Procurement** pursuant to Section 53 (1) in relation with Section 35 of RA 9184; and

d) to **RECOMMEND**, finally the **APPROVAL** of aforementioned finding and recommendations.
