Declaring 2nd Failure of Bidding; and Recommending Approval

WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the MGEPS and PAGASA Bulletin board continuously for 7 days from **12 to 19 March 2025**, the procurement of the following goods/items project described hereunder, with its corresponding Approved Budget for the Contract (ABC), under the reference, **P.R. No. 2024-10-0692 EPA / I.B. No. 2025-12 R** to wit:

WHEREAS, on **03 April 2025**, the re-scheduled **Submission, Receipt and Opening** of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), **no bids were** received by the BAC for the above-entitled Project;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) to **DECLARE**, the **2nd failure of bidding** for the above-entitled Project”;
- b) to **RECOMMEND**, that resort to the alternative method of procurement, through **Negotiated Procurement – Two Failed Biddings** pursuant to Section D. 1, Annex “H” in relation with Section 53.1 of the IRR of RA 9184; and
- c) to **RECOMMEND**, finally, the **APPROVAL** of aforementioned finding and recommendations.
