**Resolution Declaring Single Calculated Responsive Bid (SCRB)
and Recommending Award and Approval**

WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the G-EPS and PAGASA Bulletin board continuously for 7 days from **24 November - 01 December 2021** the procurement of the following goods/items described hereunder, with its corresponding Approved Budget for the Contract (ABC), under **PR No. 2021-08-0558** and **ITB 2021-059**, to wit:

WHEREAS, the provision of R.A. 9184 and its Revised Implementing Rules and Regulations (IRR), other pertinent guidelines and procedures relative to government procurement system are hereby observed and strictly implemented for the whole duration of this bidding activity;

WHEREAS, in response to the said invitation, only **Tekzone Computer Sales and Services, Inc.** expressed their intention to participate in the bidding of the aforesaid Project, and attended the **Pre-Bid Conference** conducted by the PAGASA-BAC on **02 December 2021**;

WHEREAS, on **14 December 2021**, the **schedule for submission and opening** of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), only **Tekzone Computer Sales and Services, Inc.** timely submitted their bid tenders for the Project and passed the preliminary examination of bids;
