## Declaring as Single Calculated Responsive Bid (SCRB); Recommending Award of Contract and Approval

WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website and PAGASA Bulletin board continuously for 7 days from 07-14 September 2022, the procurement of the following civil works/infrastructure project described hereunder, with its corresponding Approved Budget for the Contract (ABC), under the reference, P.R. No. 2022-03-0265/ I.B. No. 2022-003INF, to wit:

WHEREAS, in response to the above advertisement, only two (2) prospective bidder/s, namely: (1) KB Konstrak Bilding Solusyons and (2) Jessie Construction Services., expressed their respective intentions to participate in the bidding of the aforesaid Project and attended in the scheduled Pre-bid Conference conducted by the PBAC on 19 September 2022;

WHEREAS, any and all noted deviations/amendments appurtenant to the Project had been issued through a Supplemental Bid/Bulletin (SBB), with reference to Addendum No. 2022-003-01 INF Re bid dated 30 September 2022 and herein made part of this Resolution as Annex "A";

WHEREAS, on 10 October 2022, the amended schedule for Submission and Opening of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), however, only one prospective bidder, JESSIE CONSTRUCTION SERVICES, timely submitted its tender documents for the Project and passed the preliminary evaluation of bids;

WHEREAS, in the subsequent opening of Envelope No. II, the lone bidder's financial proposal has been accepted for not exceeding the ABC. Its bid tender, "as Read", is as follows:

**WHEREAS**, on 24 October 2022 the report on the detailed evaluation of bids conducted by the TWG resulted in the following:

WHEREAS, a thorough background investigation has been conducted to verify the lone bidder's performances on its on-going and completed Projects with PAGASA and other agencies; and, the report submitted by the TWG on Jessie Construction Services' performance evaluation reveals that the latter has complied accordingly on its contractual obligations;

WHEREAS, upon careful examination, validation and verification of Jessie Construction Services tender documents, including the evaluation report submitted by the TWG, the PAGASA-BAC determined that the, lone bidder has complied accordingly on all the criteria for post-qualification and was responsive on all requirements and conditions specified in the Bidding Documents.

Hence, it was moved and duly seconded that **Jessie Construction Services** be declared as the bidder with the **Single Calculated and Responsive Bid (SCRB)** for the Project.

- a) to DECLARE, Jessie Construction Services, as the bidder with the Single Calculated and Responsive Bid (SCRB) for the Project entitled, "Repair/Rehab of Itbayat Synoptic Station – Re bid" in the total calculated amount of EIGHT MILLION SIX HUNDRED FORTY-FOUR THOUSAND FIVE HUNDRED FORTY-TWO PESOS and 80/100 (Php8,644,542.80) ONLY.
- b) to **RECOMMEND**, the award of the contract to **Jessie Construction Services** for the implementation of the above-entitled Project; and
- c) to RECOMMEND, finally, the APPROVAL of the foregoing findings and recommendations.
