**Declaring Single Calculated and Responsive Bid (SCRB); and,
 Recommending Award of Contract and Approval**

WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the MGEPS and PAGASA Bulletin board continuously for 7 days from **17 to 14 December 2022**, the procurement of the following goods/items described hereunder, with its corresponding Approved Budget for the Contract (ABC), under the reference, **P.R. No. 2022-10-0882 Re bid / I.B. No. 2022-034 Re bid**, to wit:

WHEREAS, in response to the above advertisement, **no prospective bidder/s**, expressed its intention to participate in the bidding of the aforesaid Project, on the scheduled **Pre-bid conference** conducted by the PBAC on **15 December 2022**;

WHEREAS, on **27 December 2022**, the schedule for **Submission, Receipt and Opening** of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), **two (2) participating bidder/s**, namely: (1) Gilcor Printing Press and (2) Cover and Pages Corporation timely submitted their bid tender documents for the Project; however, **Gilcor Printing Press** has been declared by the PAGASA-BAC as “Disqualified” due to **failure to comply with the instruction to bidders**;

WHEREAS, applying the non-discretionary “**Pass/Fail**” criterion in the evaluation of bids, the PAGASA-BAC declared the outright rejection of the bidder/s documents based on the foregoing findings;

WHEREAS, in the subsequent opening of Envelope No. II, the remaining bidder’s financial proposal has been accepted by the PAGASA-BAC having complied with the financial requirements of the Project. The **Cover and Pages Corporation** bid tender, “**as Read**”, is summarized as follows:

**Declaring Lowest Calculated and Responsive Bid (LCRB);
 Recommending Award of Contract and Approval**

WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the MGEPS and PAGASA Bulletin board continuously for 7 days from **14 to 21 October 2022**, the procurement of the following goods/items described hereunder, with its corresponding Approved Budget for the Contract (ABC), under the reference, **P.R. No. 2022-09-0707 / I.B. No. 2022-031**, to wit:

WHEREAS, in response to the above advertisement, **three (3)** prospective bidders, enumerated hereunder, expressed their respective intentions to participate in the above bidding activity, to wit:

- Gentec Distribution Corp. and Hyquest Solutions Pty Ltd. Joint Venture;**
- Massive Integrated Tech Solutions, Inc.; and**
- Pinnacle Technologies**

WHEREAS, it was noted that only prospective bidders, Gentec Distribution Corp. and Massive Integrated Tech Solutions, Inc. attended the **Pre-bid Conference** on **16 November 2022** scheduled by the BAC for this purpose;

WHEREAS, any and all noted deviations/amendments appurtenant to the Project had been issued through a **Supplemental Bid/Bulletin (SBB)**, with reference, **Addendum No. 2022-031-01** dated **02 November 2022**, and herein made part of this Resolution as **Annex "A"**;

WHEREAS, on **16 November 2022**, the amended schedule for **Submission, Receipt and Opening** of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), the **three (3) participating bidders**, timely submitted their respective tender documents and passed the preliminary evaluation of Technical Requirements;

WHEREAS, the subsequent opening of their respective financial proposals for the Project resulted and summarized as follows:

WHEREAS, the report on the detailed evaluation of bids conducted by the TWG resulted in the disqualification of two (2) bidders, namely: Pinnacle Technologies, Inc. and Gentec Distribution Corp. & Hyquest Solutions Pty Ltd. JV due to their failure to comply and response accordingly with the Instructions to Bidders and the specific requirements of the Project, the details of which were indicated in the respective Notice of Disqualification issued by the BAC to the said bidders and hereto attached and made part of this Resolution as **Annexes "B" & "C"**;

WHEREAS, on **06 December 2022**, the PBAC issued a Notice of Disqualification to all the participating bidders. Copies of the Notice of Disqualification are hereto attached marked as **Annex "B" and Annex "C"**;

WHEREAS, the above bidders submitted their respective appeals to the said BAC findings; however, upon careful and due deliberation thereof, the BAC found no substantial reason to depart from the earlier decision to disqualify both bidders and unanimously concurred to **deny** their requests for reconsideration. (See **Annexes "D" & "E"**, hereof)

WHEREAS, upon careful examination, validation and verification of **Massive Integrated Tech Solutions Inc.** tender documents, including the evaluation report submitted by the TWG, the PAGASA-BAC determined that the latter has complied accordingly on all the criteria for post-qualification and was responsive on all requirements and conditions specified in the Bidding Documents.

Hence, it was moved and duly seconded that **Massive Integrated Tech Solutions Inc.** be declared as the bidder with the **Lowest Calculated and Responsive Bid (LCRB)** for the Project.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) to **DECLARE, Massive Integrated Tech Solutions Inc.,** as the Bidder with the Lowest Calculated and Responsive Bid (SCRB) for the Project entitled, *“Supply, Delivery, Installation, Configuration, Testing, Training and Commissioning of Hydrological Monitoring Facilities for the Ilog Hilabangan River Flood Forecasting and Warning System;”* in the total calculated amount of **FOURTEEN MILLION EIGHT HUNDRED FIFTY-NINE THOUSAND THREE HUNDRED FORTY-TWO PESOS & 16/100 (Php14,859,342.16)** only;
- b) to **RECOMMEND**, the award of the contract to **Massive Integrated Tech Solutions Inc.** for the implementation of the above-entitled Project; and
- c) to **RECOMMEND**, finally, the **APPROVAL** of the foregoing findings and recommendations.
