**Declaring Single Calculated and Responsive Bid (SCRB); and,
 Recommending Award of Contract and Approval**

WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the MGEPS and PAGASA Bulletin board continuously for 7 days from **17 to 14 December 2022**, the procurement of the following goods/items described hereunder, with its corresponding Approved Budget for the Contract (ABC), under the reference, **P.R. No. 2022-10-0881 Re bid / I.B. No. 2022-035 Re bid**, to wit:

WHEREAS, in response to the above advertisement, **two (2)** prospective bidder/s, (1) **Weather Bureau Multipurpose Cooperative (WBMP)**, (2) **Tanjer Enterprises** expressed their intention to participate in the said bidding activity and attended the **Pre-bid conference** on **15 December 2022** scheduled for this purpose;

WHEREAS, on **27 December 2022**, the schedule for **Submission, Receipt and Opening** of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), **only Tanjer Enterprises**, timely submitted its tender documents for the project and passed the preliminary examination of bids;

WHEREAS, in the subsequent opening of Envelope No. II, the lone bidder's financial proposal has been accepted for not exceeding the ABC. Its bid tender, "**as Read**", is as follows:
