WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the G-EPS and PAGASA Bulletin board continuously for 7 days from **02 to 09 March 2022**, the procurement of the following goods/items described hereunder, with its corresponding Approved Budget for the Contract (ABC), under the reference, **P.R. No. 2022-01-0053/ I.B. No. 2022-007DC**, to wit:

- to **DECLARE**, a **Failure of Bidding** for the above-entitled Project;
- to **RECOMMEND** the mandatory review and evaluation of terms, conditions and specifications of the project, pursuant to Section 35 of the IRR of RA 9184; and the immediate **re-posting** thereof for re-bidding purposes; and
- to **RECOMMEND**, finally, the **APPROVAL** of aforementioned finding and recommendations.
