**Resolution Declaring 1st Failure of Bidding;
 and Recommending Approval**

Resolution No. 2022-033

WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, posted the Notice to Bidders on **01 April 2022** at the PAGASA website and PAGASA Bulletin, notifying the public of its resort to alternative method of procurement through **Negotiated Procurement after Two Failed Biddings**, pursuant to *Section V (D.3 (a.i) & (b.iv)), Annex "H" of the Revised IRR of RA9184*, the procurement of the following goods/items described hereunder, with its corresponding Approved Budget for the Contract (ABC), under the reference, **P.R. No. 2021-09-0640/ I.B. No. 2022-004 NP**, to wit:

WHEREAS, in response to the said invitation, **only one (1) prospective bidder, ENHANCED ELECTRONICS AND COMMUNICATION SERVICES, INC.** expressed its intention to participate in the said bidding activity and attended the **Pre-negotiation Conference** scheduled by the Bids and Awards Committee on **11 April 2022**. On the other hand, the BAC, through the BAC Secretariat received a letter from **CONSTRUCTICONS, INC.**, dated 06 April 2022¹, informing the Body of its on-going assessment and mechanical evaluation of the subject Iloilo Radar equipment;
