**Resolution Declaring 2nd Failure of Bidding;
and Recommending Approval**

WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, posted the Notice to Bidders on **01 April 2022** at the PAGASA website and PAGASA Bulletin, notifying the public of its resort to alternative method of procurement through Direct Contracting of the following goods/items described hereunder, with its corresponding Approved Budget for the Contract (ABC), under the reference, **P.R. No. 2022-01-0053/ I.B. No. 2022-008 DC**, to wit:

WHEREAS, on **04 April 2022**, by virtue of the same Notice to Bidders, the Bids and Awards Committee invited the company, **TRANE PHILIPPINES, INC.**, the sole distributor/exclusive dealer and service provider of the subject equipment in the Philippines, to participate in the procurement process for the above-entitled project; which the latter accepted and attended the Pre-bid/Pre-negotiation Conference on 11 April 2022 scheduled for this purpose;

WHEREAS, any and all noted amendments and deviations discussed during the above-mentioned Pre-bid conference, including the succeeding schedules of bidding process had been duly issued through SBB No. 1, dated 19 April 2022, hereto attached and made part of this Resolution as **Annex "A"**;

WHEREAS, on **25 April 2022**, the amended schedule for **Submission, Receipt and Opening** of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), the above-mentioned bidder failed to timely submit its tender documents for the instant Project; thus, prompting the BAC to declare a 2nd Failure of Bidding.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) to **DECLARE**, the **2nd Failure of Bidding** for the above-entitled Project;
- b) to **RECOMMEND**, the immediate conduct of negotiation with the said company considering the urgency in the acquisition and completion of the Project; and
- c) to **RECOMMEND**, finally, the **APPROVAL** of aforementioned finding and recommendations.
