**Resolution Declaring 2nd Failure of Bidding;
 and Recommending Approval**

WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the MGEPS and PAGASA Bulletin board continuously for 7 days from **27 April 2022 to 04 May 2022**, the **Re-bid** of the following goods/items described hereunder, with its corresponding Approved Budget for the Contract (ABC), under the reference, **P.R. No. 2021-10-0005 EPA / I.B. No. 2022-005 Re-bid**, to wit:

WHEREAS, in response to the above advertisement, **only one (1)** prospective bidder, **SANDERLAND CORPORATION**, expressed its intention to participate in the said bidding activity and attended the Pre-bid Conference on 16 May 2022 scheduled for this purpose;

WHEREAS, any and all noted amendments and deviations discussed during the above-mentioned Pre-bid conference, including the succeeding schedules of bidding process had been duly issued through a **Supplemental Bid/Bulletin (SBB)**, with reference to **Addendum No. 2022-005-01** dated 04 May 2022 and herein made part of this Resolution as **Annex “A”**;

WHEREAS, on **30 May 2022**, the amended schedule for **Submission, Receipt and Opening** of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), the lone bidder timely submitted its tender documents for the project; however, failed to pass the preliminary evaluation of bids due to **failure to comply with the technical documents to be submitted**, more specifically, **“C-2 failure to submit Copy of Certificate of Completion or Sales Invoice and C-3 Copy of Certificate of Acceptance or Official Receipt (OR) / Collection Receipt.”**

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) to **DECLARE**, the **2nd Failure of Bidding** for the above-entitled Project;
- b) to **RECOMMEND**, the immediate conduct of negotiation with the said company considering the urgency in the acquisition and completion of the Project; and
- c) to **RECOMMEND**, finally, the **APPROVAL** of aforementioned finding and recommendations.
