## Declaring Failure of Negotiated Procurement under Section V (D.3); and Recommending Approval

WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, posted the Notice to Bidders on 27 June 2022 at the PAGASA website and PAGASA Bulletin, notifying the public of its resort to alternative method of procurement through *Negotiated Procurement after Two Failed Biddings*, pursuant to *Section V (D.3 (a.i) & (b.iv) ), Annex "H" of the Revised IRR of RA9184*, the procurement of the following goods/items described hereunder, with its corresponding Approved Budget for the Contract (ABC), under the reference, P.R. No. 2022-01-0053 / NB. No. 2022-006 NP, to wit:

WHEREAS, on 27 June 2022, by virtue of the same Notice to Bidders and in compliance with the foregoing procurement rules and procedures, the following prospective bidders who were identified and listed under PAGASA's list of legitimate suppliers had been duly invited:

- 1. SMS Global Technologies, Inc.
- 2. Superserve Corporation
- 3. Coffel Aire Industries, Inc.

WHEREAS, in response to the said invitation, only one (1) prospective bidder, SMS Global Technologies, Inc., expressed its intention to participate in the said bidding activity and attended the Pre-negotiation Conference scheduled by the PAGASA-BAC for this purpose and purchased the required bidding documents;

WHEREAS, prior to the scheduled submission and receipt of bid proposals, another prospective bidder, Filairco, Inc. also expressed its intention to participate in the bidding activities thereof by purchasing the required bidding documents;

WHEREAS, on 19 July 2022, the schedule for Submission, Receipt and Opening of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component); however, no bid offer was received by the BAC.

**NOW, THEREFORE, We,** the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED:** To,

a) DECLARE, a Failure of Negotiated Procurement for the above-entitled Project;

- b) **RECOMMEND**, the mandatory review and evaluation of terms, conditions and specifications of the project, pursuant to Section 35 of the IRR of RA 9184;
- c) **RECOMMEND, further,** the timely review and revision by the end-user unit of the requirements and technical specifications of the Project; and

d) **RECOMMEND**, finally, the **APPROVAL** of the foregoing findings and recommendations.
