**Declaring Single Calculated Responsive Bid (SCRB); and,  
 Recommending Award of Contract and Approval**

**WHEREAS**, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the MGEPS and PAGASA Bulletin board continuously for 7 days from **28 June to 05 July 2022**, the procurement of the following goods/items described hereunder, with its corresponding Approved Budget for the Contract (ABC), under the reference, **P.R. No. 2022-06-0505 / I.B. No. 2022-020**, to wit:

**WHEREAS**, the provision of R.A 9184 and its Revised Implementing Rules and Regulations (IRR), other pertinent guidelines and procedures relative to government procurement system are hereby observed and strictly implemented for the whole duration of this bidding activity;

**WHEREAS**, in response to the above advertisement, **only one (1)** prospective bidder, **COFFEL AIRE INDUSTRIES, INC.**, expressed its intention to participate in the said bidding activity and attended the **Pre-bid conference** on **06 July 2022** scheduled for this purpose;

**WHEREAS**, on **19 July 2022**, the scheduled **Submission, Receipt and Opening** of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), **only COFFEL AIRE INDUSTRIES, INC.** timely submitted its tender documents for the project and passed the preliminary examination of bids;
