**Resolution Declaring Failure of Bidding for the Negotiated Procurement –  
Two-Failed Biddings; and Recommending Approval**

**WHEREAS**, the PAGASA Bids and Awards Committee, by virtue of its Resolution No. 2022-056, s.2022, posted the Notice to Bidders on 02 August 2022 at the PAGASA website and PAGASA Bulletin, notifying the public of its resort to alternative method of procurement through **Negotiated Procurement after Two Failed Biddings**, pursuant to *Section V (D.3 (a.i) & (b.iv) ), Annex "H" of the Revised IRR of RA9184*, the procurement of the following goods/items described hereunder, with its corresponding Approved Budget for the Contract (ABC), under the reference, **P.R. No. 2022-04-0305 / NB. No. 2022-009 NP**, to wit:
