Resolution No. 2022-070

Declaring as Single Calculated Responsive Bid (SCRB); Recommending Award and Approval

WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website and PAGASA Bulletin board continuously for 7 days from 25 July to 01 August 2022, the procurement of the following civil works/infrastructure project described hereunder, with its corresponding Approved Budget for the Contract (ABC), under the reference, P.R. No. 2022-06-0493 / I.B. No. 2022-002 INF Re bid, to wit:

WHEREAS, in response to the above advertisement, three (3) prospective bidders, namely: (1) Lacozte Construction, (2) Extreme Builders, and (3) GR8 Builders Construction expressed their respective intentions to participate in the bidding of the aforesaid Project; however, only prospective bidder nos. 1 & 2 attended the Pre-bid Conference conducted by the PBAC on 2 August 2022;

WHEREAS, any and all noted amendments and deviations discussed during the abovementioned Pre-bid conference, has been duly issued through a **Supplemental Bid Bulletin** (SBB), with reference to Addendum No. 2022-002 INF Re bid-01 dated 06 July 2022 and Addendum No. 2022-002 INF Re bid-02 dated 15 August 2022 are herein made part of this Resolution as Annex "A" and Annex "B";

WHEREAS, on 15 August 2022, the schedule for Submission and Opening of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), only two (2) participating bidder/s, namely: (1) GR8 Builders Construction, and (2) Extreme Builders submitted their tender documents for the Project; however, Extreme Builders has been declared by the PAGASA-BAC as "Disqualified" due to failure to comply with the simple instruction to bidders, more specifically, *non-compliance with the marking and sealing of envelopes*. Accordingly, it was determined based on the labels of the envelopes submitted that there were four (4) envelopes that were labeled as "Technical Documents" while only two (2) envelopes were labeled as "Financial Documents";

WHEREAS, in the subsequent opening of Envelope No. II, the remaining bidder's financial proposal has been accepted by the PAGASA BAC having complied with the financial requirements of the Project. The **GR8 Builders Construction**'s bid tender, **"as Read"**, is summarized as follows:

WHEREAS, the report on the detailed evaluation of bids conducted by the TWG resulted in the following:

WHEREAS, upon careful examination, validation and verification of GR8 BUILDERS CONSTRUCTION's tender documents, including the evaluation report submitted by the TWG, the PAGASA-BAC determined that, the **Ione bidder** has complied accordingly on all the criteria for post-qualification and was responsive on all requirements and conditions specified in the Bidding Documents. Hence, it was moved and duly seconded that the GR8 BUILDERS CONSTRUCTION be declared as the bidder with the Single Calculated and Responsive Bid (SCRB) for the Project.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) to DECLARE, GR8 BUILDERS CONSTRUCTION, as the bidder with the Single Calculated and Responsive Bid (SCRB) for the Project entitled, "Improvement of Existing Access Road, Pathway and Perimeter Pavement of Building at ISU – Echague, Isabela – Re bid" in the total calculated amount of ONE MILLION FOUR HUNDRED SIXTY-NINE THOUSAND SEVEN HUNDRED THIRTY-TWO PESOS and 69/100 (Php1,469,732.69) ONLY.
- b) to RECOMMEND, the award of the contract to GR8 BUILDERS CONSTRUCTION for the implementation of the above-entitled Project; and
- c) to RECOMMEND, finally, the APPROVAL of the foregoing findings and recommendations.
