**Resolution Declaring 2nd Failure of Bidding;
 Recommending Resort to Alternative Method of Procurement thru
 Negotiated Procurement – Two-Failed Biddings; and
 Recommending Approval**

WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website and PAGASA Bulletin board continuously for 7 days from **09-16 September 2022**, the procurement of the following goods/items described hereunder, with its corresponding Approved Budget for the Contract (ABC), under the reference, **P.R. No. 2022-04-0335/ I.B. No. 2022-022 Re bid**, to wit:
