Resolution No. 2022-093

**Declaring Single Calculated and Responsive Bid (SCRB); and,
 Recommending Award of Contract and Approval**

WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the MGEPS and PAGASA Bulletin board continuously for 7 days from **07 October to 14 October 2022**, the procurement of the following goods/items described hereunder, with its corresponding Approved Budget for the Contract (ABC), under the reference, **P.R. No. 2022-09-0785 / I.B. No. 2022-028**, to wit:

WHEREAS, in response to the above advertisement, **only one (1) prospective bidder/s, RNET and RJ4 General Merchandise**, expressed its intention to participate in the said bidding activity and attended the **Pre-bid conference on 17 October 2022** scheduled for this purpose;

WHEREAS, on **03 November 2022**, the schedule for **Submission, Receipt and Opening** of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), **only RNET and RJ4 General Merchandise**, timely submitted its tender documents for the project and passed the preliminary examination of bids;

WHEREAS, in the subsequent opening of Envelope No. II, the lone bidder's financial proposal has been accepted for not exceeding the ABC. Its bid tender, "**as Read**", is as follows:

WHEREAS, on **07 November 2022**, the TWG reported to the BAC that they were not able to proceed with the evaluation due to non-inclusion of the brand name on the submitted proposal. The TWG was not able to confirm the veracity of the brochure submitted. The BAC recommends to the TWG that they may require the bidder in writing to re-submit the requested documents if it will be helpful in the conduct of the evaluation;

WHEREAS, on **16 November 2022**, the report on the detailed evaluation of bids conducted by the TWG resulted in the following:

WHEREAS, upon careful examination, validation and verification of **RNET and RJ4 General Merchandise**, tender documents, including the evaluation report submitted by the TWG, the PAGASA-BAC determined that, **the lone bidder** has complied accordingly on all the criteria for post-qualification and was responsive on all requirements and conditions specified in the Bidding Documents. Hence, it was moved and duly seconded that the **RNET and RJ4 General Merchandise**, be declared as the bidder with the **Single Calculated and Responsive Bid (SCRB)** for the Project.
