



**PAGASA BIDS AND AWARDS COMMITTEE (PBAC)**

Resolution No. 2023-077

**Declaring Lowest Calculated and Responsive Bid (LCRB); and,  
 Recommending Award of Contract and Approval**

**WHEREAS**, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, posted the Notice to Bidders on **06 November 2023** at the PAGASA Website and PAGASA Bulletin Board, notifying the public of its resort to alternative method of procurement through **Negotiated Procurement after Two Failed Biddings**, pursuant to *Section V (D.3 (a.i) & (b.iv) ) , Annex "H" of the Revised IRR of RA9184*, the procurement of the following goods/items described hereunder with its corresponding Approved Budget for the Contract (ABC), under the reference, **P.R. No. 2023-06-0396 / I.B. No. 2023-002 NP**, to wit:

**WHEREAS**, on **06 November 2023**, by virtue of the same Notice to Bidders, the Bids and Awards Committee invited the following prospective bidders who were identified and listed under PAGASA's list of legitimate suppliers as accredited suppliers of various radar parts and equipment:

**WHEREAS**, in response to the said invitation, **two (2)** prospective bidders namely; 1) **Sanderland Corporation** and, 2) **Bluebell Corporation of the Philippines** expressed its intention to participate in the bidding of the aforesaid Project, on the scheduled **Pre-negotiation Conference** conducted by the PBAC on **13 November 2023**;

**WHEREAS**, on **16 November 2023**, the schedule for **Submission, Receipt and Opening** of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), **two (2)** prospective bidders namely; 1) **Bluebell Corporation of the Philippines** and, 2) **Sanderland Corporation** timely submitted their bid tender documents for the project and passed the preliminary evaluation of bids;

**WHEREAS**, in the subsequent opening of Envelope No. II (Financial Component), the financial proposal of the two bidder has been accepted by the PAGASA-BAC having complied with the financial requirements of the project; Its financial proposal, as "**Read**", is summarized hereunder, as follows:

- a) to **DECLARE, Bluebell Corporation of the Philippines** as the Bidder with the Lowest Calculated and Responsive Bid (LCRB) for the Project entitled, "*Supply and Delivery of Various ICT Equipment GCF-IBFPh Project; Lot C Mobile Communication Devices-NP*";
- b) to **RECOMMEND**, the award of the contract to **Bluebell Corporation of the Philippines**, in the total calculated amount of **One Million Five Hundred Ninety Eight Thousand Pesos (Php1,598,000.00)** only, for the implementation of the Project; and
- c) to **RECOMMEND** finally, the **APPROVAL** of the foregoing findings and recommendations.
