**WHEREAS**, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, posted the Notice to Bidders (NTB) on 04 December 2023 at the PAGASA Website and PAGASA Bulletin Board, notifying all interested bidders of the Agency's resort to Alternative Mode of Procurement through Direct Contracting under the Rule XVI, Section 50 of the revised IRR of RA9184 for the procurement of the project "Procurement of WEB Hosting Service" described hereunder, with its corresponding Approved Budget for the Contract (ABC), under the reference, **P.R.
