WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the MGEPS and PAGASA Bulletin board continuously for 7 days from 20 to 28 Nov 2023, the procurement of the following goods/items described hereunder, with its corresponding Approved Budget for the Contract (ABC), under the reference, P.R. WHEREAS, in response to the above advertisement, only one (1) prospective bidder, E-Copy Corporation expressed its intention to participate in the bidding of the aforesaid Project, on the scheduled Pre-bid conference conducted by the PBAC on 29 November 2023;

WHEREAS, any and all noted amendments and deviations discussed during the above-mentioned Pre-bid conference, have been duly issued through a **Supplemental Bid Bulletin (SBB)**, with reference to **Addendum No. 2023-024-01** dated 01 December 2023 are herein made part of this Resolution as **Annex** "A";

WHEREAS, on 18 December 2023, the schedule for Submission, Receipt and Opening of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), E-Copy Corporation, timely submitted its bid tender documents for the project and passed the preliminary examination of bids;

WHEREAS, in the subsequent opening of Envelope No. II (Financial Component), the lone bidder's financial proposal has been accepted for not exceeding the ABC. Its financial proposal, as "Read", is as follows:
