## Declaring Single Calculated and Responsive Bid (SCRB); and, Recommending Award of Contract and Approval

WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the MGEPS and PAGASA Bulletin board continuously for 7 days from 22 to 29 Jan 2024, the procurement of the following goods/items projects described hereunder, with its corresponding Approved Budget for the Contract (ABC), under the reference, P.R. No. 2023-12-0684 EPA / I.B. No. 2024-01 to wit:

WHEREAS, in response to the above advertisement, three (3) prospective bidder namely: (1) Ultra Security Services, Inc.; (2) Nonagon Security Services Inc., and (3) Lifeguard Archangels Security Agency Corporation expressed their intention to participate in the bidding of the aforesaid Project, on the scheduled Pre-bid conference conducted by the PBAC on 30 January 2024;

WHEREAS, any and all noted amendments and deviations discussed during the above-mentioned Pre-bid conference, have been duly issued through a **Supplemental Bid Bulletin (SBB)**, with reference to **Addendum No. 2024-01 01** dated 02 February 2024 and **Addendum No. 2024-01 02** dated 07 February 2024 are herein made part of this Resolution as **Annex "A" and Annex "B**" respectively;

WHEREAS, on 13 February 2024, the re-scheduled Submission, Receipt and Opening of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), only Lifeguard Archangels Security Agency Corporation timely submitted its bid tender documents for the project and passed the preliminary examination of bids;

WHEREAS, in the subsequent opening of Envelope No. II (Financial Component), the lone bidder's financial proposal has been accepted for not exceeding the ABC. Its financial proposal, as "Read", is as follows:

WHEREAS, upon careful examination, validation and verification of lone bidder documents, including the evaluation report submitted by the TWG, the PAGASA-BAC determined that Lifeguard Archangels Security Agency Corporation has complied accordingly on all the criteria for post-qualification and was responsive to all requirements and conditions specified in the Bidding Documents.

- b) to RECOMMEND, the award of the contract to Lifeguard Archangels Security Agency Corporation in the actual bid amount of Forty Million Three Hundred Seven Thousand Three Hundred Seventy Nine Pesos and 48/100 (Php40,307,379.48) for the implementation of the Project; and
- c) to **RECOMMEND** finally, the **APPROVAL** of the foregoing findings and recommendations.
