



**PAGASA BIDS AND AWARDS COMMITTEE (PBAC)**

**Resolution No. 2024-016**

**Declaring Lowest Calculated and Responsive Bid (LCRB); and,  
 Recommending Award of Contract and Approval**

**WHEREAS**, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the MGEPS and PAGASA Bulletin board continuously for 7 days from **8 to 15 April 2024**, the procurement of the following goods/items projects described hereunder, with its corresponding Approved Budget for the Contract (ABC), under the reference, **P.R. No. 2024-02-0180 / I.B. No. 2024-08** to wit:

**WHEREAS**, in response to the above advertisement, **three (3) prospective bidder/s** namely: (1) **Metronix Inc.**; (2) **West Point Engineering Supplies**; and (3) **Chomar Unitrade** expressed their intention to participate in the bidding of the aforesaid Project, on the scheduled **Pre-bid conference** conducted by the PBAC on **16 April 2024**;

**WHEREAS**, **one (1) prospective bidder/s**, (4) **P.T. Cerna Corporation** also expressed its intention to participate in the bidding activities thereof by purchasing the required bidding documents;

**WHEREAS**, any and all noted amendments and deviations discussed during the above-mentioned Pre-bid conference, have been duly issued through a **Supplemental Bid Bulletin (SBB)**, with reference to **Addendum No. 2024-08 01** dated 19 April 2024 is herein made part of this Resolution as **Annex "A"**;

**WHEREAS**, on **30 April 2024**, the scheduled **Submission, Receipt and Opening** of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), **two (2) prospective bidders** namely: (1) **West Point Engineering Supplies**; and (2) **P.T. Cerna Corporation** timely submitted their bid tender documents for the project and passed the preliminary examination of bids;

**WHEREAS**, in the subsequent opening of Envelope No. II (Financial Component), the bidder's financial proposal has been accepted for not exceeding the ABC. Its financial proposal, as "**Read**", is as follows:

the Bidding Documents. Hence, it was moved and duly seconded that **P.T. Cerna Corp.** be declared as the **Lowest Calculated and Responsive Bidder (LCRB)** for the Project.


**NOW, THEREFORE, We**, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) to **DECLARE, P.T. Cerna Corp.** as the Bidder with the Lowest Calculated and Responsive Bid (LCRB) for the Project entitled, "*Supply and Delivery of 18 units of Barometric Pressure Sensors, 28 units of Temperature/Humidity Sensors and 8 units of Wind Vane Anemometer/Direction*";
- b) to **RECOMMEND**, the award of the contract to **P.T. Cerna Corp.** in the actual bid amount of **Four Million Eight Hundred Sixty-Seven Thousand Five Hundred Forty Pesos (Php4,867,540.00)** only for the implementation of the Project; and
- c) to **RECOMMEND** finally, the **APPROVAL** of the foregoing findings and recommendations.
