Declaring 2nd Failure of Bidding; and Recommending Approval

WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the MGEPS and PAGASA Bulletin board continuously for 7 days from **31 July to 07 August 2024**, the procurement of the following civil works/infrastructure project described hereunder, with its corresponding Approved Budget for the Contract (ABC), under the reference, **P.R. No. 2024-06-0430 / I.B. No. 2024-29 INF_R** to wit:

WHEREAS, on **20 August 2024**, the schedule for **Submission, Receipt and Opening** of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), **no bids were** received by the BAC for the above-entitled Project;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) to **DECLARE**, the **2nd failure of bidding** for the above-entitled Project";
- b) to **RECOMMEND**, that resort to the alternative method of procurement, through **Negotiated Procurement – Two Failed Biddings** pursuant to Section D. 1, Annex "H" in relation with Section 53.1 of the IRR of RA 9184; and
- c) to **RECOMMEND**, finally, the **APPROVAL** of aforementioned finding and recommendations.
