## PAGASA BIDS AND AWARDS COMMITTEE (PBAC)

Resolution No. 2024-049

Declaring Single Calculated and Responsive Bid (SCRB); and, Recommending Award of Contract and Approval

WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the MGEPS and PAGASA Bulletin board continuously for 7 days from 06 to 13 August 2024, the procurement of the following goods/items projects described hereunder, with its corresponding Approved Budget for the Contract (ABC), under the reference, P.R. No. 2024-07-0520 / I.B. No. 2024-32 to wit:

WHEREAS, in response to the above advertisement, only one (1) prospective bidder Metronix Inc. expressed its intention to participate in the bidding of the aforesaid Project, on the re-scheduled Pre-bid conference conducted by the PBAC on 27 August 2024;

WHEREAS, any and all noted amendments and deviations discussed during the above-mentioned Pre-bid conference, have been duly issued through a Supplemental Bid Bulletin (SBB), with reference to Addendum No. 2024-32 01 dated 15 August 2024; and Addendum No. 2024-32 02 dated 20 August 2024 are herein made part of this Resolution as Annex "A" and Annex "B" respectively;

WHEREAS, on 10 September 2024, the re-scheduled Submission, Receipt and Opening of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), Metronix Inc. timely submitted its bid tender documents for the project and passed the preliminary examination of bids;

WHEREAS, in the subsequent opening of Envelope No. II (Financial Component), the lone bidder financial proposal has been accepted for not exceeding the ABC. Its financial proposal, as "Read", is as follows:

WHEREAS, upon careful examination, validation and verification of the lone bidder tender documents, including the evaluation report submitted by the TWG, the PAGASA-BAC determined that Metronix Inc., has complied accordingly with all the criteria for post-qualification and was responsive to all requirements and conditions specified in the Bidding Documents. Hence, it was moved and duly seconded that Metronix Inc. be declared as the Single Calculated and Responsive Bidder (SCRB) for the Project.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) to DECLARE, Metronix Inc. as the Bidder with the Single Calculated and Responsive Bid (SCRB) for the Project entitled, "Supply and Delivery of Wind and Rain Meteorological Equipment",
- b) to RECOMMEND, the award of the contract to Metronix Inc., in the total amount of Four Million Four Hundred Fifty Thousand Pesos (Php4,450,000.00) only for the implementation of the Project; and
- c) to RECOMMEND finally, the APPROVAL of the foregoing findings and recommendations.
