**Declaring Lowest Calculated and Responsive Bid (LCRB); and,
 Recommending Award of Contract and Approval**

WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the MGEPS and PAGASA Bulletin board continuously for 7 days from **21 to 28 October 2024**, the procurement of the following goods/items projects described hereunder, with its corresponding Approved Budget for the Contract (ABC), under the reference, **P.R. No. 2024-06-0448 || I.B. No. 2024-47 R** to wit:

WHEREAS, in response to the above advertisement, **two (2)** prospective bidders namely: 1) **Metronix, Inc.** and 2) **State Alliance Enterprises**, expressed their intention to participate in the bidding of the aforesaid Project, on the scheduled **Pre-bid conference** conducted by the PBAC on **29 October 2024**;

WHEREAS, any and all noted amendments and deviations have been duly issued through a **Supplemental Bid Bulletin (SBB)**, with reference to **Addendum No. 2024-47 R 01** dated 22 October 2024 is herein made part of this Resolution as **Annex “A”**;

WHEREAS, on **12 November 2024**, the scheduled **Submission, Receipt and Opening** of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), **two (2) participating bidder/s**, namely; (1) **JV - Camba Corporation and State Alliance Enterprises, Inc.** and (2) **Metronix Inc.** timely submitted their bid tender documents for the project and passed the preliminary examination of bids;

WHEREAS, in the subsequent opening of Envelope No. II (Financial Component), the bidder's financial proposal has been accepted for not exceeding the ABC. Its financial proposal, as **“Read”**, is as follows:

Hence, it was moved and duly seconded that **Metronix, Inc.** be declared as the **Lowest Calculated and Responsive Bidder (LCRB)** for the Project.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) to **DECLARE, Metronix, Inc** as the Bidder with the **Lowest Calculated and Responsive Bid (LCRB)** for the Project entitled, *Supply, Delivery and Testing of Solar Radiation Monitoring Equipment – Re bid*;
- b) to **RECOMMEND**, the award of the contract to **Metronix, Inc.** in the total calculated amount of **Two Million Twenty-Nine Thousand Seven Hundred Pesos and 16/100 (Php2,029,700.16)** only for the implementation of the Project; and
- c) to **RECOMMEND** finally, the **APPROVAL** of the foregoing findings and recommendations.
