Resolution No. 2024-077

**Declaring Lowest Calculated and Responsive Bid (LCRB); and,
 Recommending Award of Contract and Approval**

WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the MGEPS and PAGASA Bulletin board continuously for 7 days from **21 to 28 October 2024**, the procurement of the following goods/items projects described hereunder, with its corresponding Approved Budget for the Contract (ABC), under the reference, **P.R. No. 2024-10-0691 EPA || I.B. No. 2024-48 EPA** to wit:

WHEREAS, in response to the above advertisement, three (3) prospective bidder/s namely: (1) **Tekzone Computer Sales and Services, Inc.**; (2) **First Data Corp.**; and (3) **COMFAC Corporation** expressed their intention to participate in the bidding of the aforesaid Project, on the scheduled **Pre-bid conference** conducted by the PBAC on **29 October 2024**;

WHEREAS, any and all noted amendments and deviations discussed during the above-mentioned Pre-bid conference, have been duly issued through a **Supplemental Bid Bulletin (SBB)**, with reference to **Addendum No. 2024-48 01** dated 22 October 2024; and **Addendum No. 2024-48 02** dated 30 October 2024 are herein made part of this Resolution as **Annex "A"** and **Annex "B"** respectively;

WHEREAS, on **12 November 2024**, the scheduled **Submission, Receipt and Opening** of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), **two (2) participating bidder/s**, namely; (1) **Tekzone Computer Sales and Services, Inc.**; and (2) **COMFAC Corporation** timely submitted their bid tender documents for the project and passed the preliminary examination of bids;

WHEREAS, in the subsequent opening of Envelope No. II (Financial Component), the bidders' financial proposal has been accepted for not exceeding the ABC. Its financial proposal, as **"Read"**, is as follows:

WHEREAS, upon careful examination, validation and verification of the two (2) bidder's tender documents, including the evaluation report submitted by the TWG, the PAGASA-BAC determined that **Tekzone Computer Sales and Services, Inc.** has complied accordingly with all the criteria for post-qualification and was responsive to all requirements and conditions specified in the Bidding Documents, However, the **COMFAC Corporation**, was found to be non-responsive. Hence, it was moved and duly seconded that **Tekzone Computer Sales and Services, Inc.** be declared as the **Lowest Calculated and Responsive Bidder (LCRB)** for the Project.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) to **DECLARE**, **Tekzone Computer Sales and Services, Inc.** as the Bidder with the **Lowest Calculated and Responsive Bid (LCRB)** for the Project entitled, *Supply, Delivery, Testing and Installation of Application Program Interface (Cloud Infrastructure Service) and Firewall*;
- b) to **RECOMMEND**, the award of the contract to **Tekzone Computer Sales and Services, Inc.** in the total calculated amount of **Three Million One Hundred Ninety-Five Thousand Pesos (Php3,195,000.00)** only for the implementation of the Project; and
- c) to **RECOMMEND FURTHER**, that the issuance of the Notice of Award (NOA), the Contract and the Notice to Proceed (NTP) be held in abeyance, pending approval and effectivity of the GAA, corporate budget, appropriations ordinance, or the loan agreement in the case of foreign-assisted projects (FAPS);
- d) to **RECOMMEND** finally, the **APPROVAL** of the foregoing findings and recommendations.
