
**NOW, THEREFORE, We**, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- b) to **RECOMMEND**, the award of the contract to **JV Camba Corporation with State Alliance Enterprises Inc.** in the total calculated amount of **One Million Eight Hundred Seventy-Three Thousand Three Hundred One Pesos & 58/100 (Php1,873,301.58)** only for the implementation of the Project; and
