**Resolution Recommending Acceptance of Lowest Price Quotation;  
 Recommending Award and Approval**

**WHEREAS**, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, posted the Notice to Bidders (NTB) on 13 December 2024 at the PAGASA Website and PAGASA Bulletin Board, notifying all interested bidders of the Agency's resort to Alternative Mode of Procurement through Direct Contracting under the Rule XVI, Section 50 of the revised IRR of RA9184 for the procurement of the project "**Preventive and Corrective Maintenance, including Provisions for Emergency Repair of Baler, Benguet and Daet Doppler Weather Radars**" described hereunder, with its corresponding Approved Budget for the Contract (ABC), under the reference, P.R. No. 2024-11-0792 EPA || I.B. No. 2024-74 DC EPA, to wit:
