WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the MGEPS and PAGASA Bulletin board continuously for 7 days from 02 to 09 December 2024, the procurement of the following goods/items projects described hereunder, with its corresponding Approved Budget for the Contract (ABC), under the reference, P.R. WHEREAS, in response to the above advertisement, two (2) prospective bidders namely; (1) MJAS Zenith Trading; and (2) Metronix, Inc. expressed their intention to participate in the bidding of the aforesaid Project, on the scheduled Pre-bid conference conducted by the PBAC on 10 December 2024;

WHEREAS, on 23 December 2024, the scheduled Submission, Receipt and Opening of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), only MJAS Zenith Trading timely submitted its bid tender documents for the project and passed the preliminary examination of bids;

WHEREAS, in the subsequent opening of Envelope No. II (Financial Component), the lone bidder financial proposal has been accepted for not exceeding the ABC. Its financial proposal, as "Read", is as follows:

WHEREAS, upon careful examination, validation and verification of the lone bidder tender documents, including the evaluation report submitted by the TWG, the PAGASA-BAC determined that MJAS Zenith Trading, has complied accordingly with all the criteria for post-qualification and was responsive to all requirements and conditions specified in the Bidding Documents. Hence, it was moved and duly seconded that MJAS Zenith Trading be declared as the Single Calculated and Responsive Bidder (SCRB) for the Project.



NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) to DECLARE, MJAS Zenith Trading the bidder with the Single Calculated and Responsive Bid (SCRB) for the Project entitled, Supply and Delivery of RTK GNSS Receiver;
- to RECOMMEND, the award of the contract to MJAS Zenith Trading in the total calculated amount of One Million Five Hundred Thirty-Nine Thousand Five Hundred Pesos (Php1,539,500.00) only for the implementation of the Project; and
- to RECOMMEND FURTHER, that the issuance of the Notice of Award (NOA), the Contract and the Notice to Proceed (NTP) be held in abeyance, pending approval and effectivity of the GAA, corporate budget, appropriations ordinance, or the loan agreement in the case of foreign-assisted projects (FAPS);
- d) to **RECOMMEND** finally, the **APPROVAL** of the foregoing findings and recommendations.
