**Resolution Declaring Single Calculated and Responsive Bidder (SCRB);
and Recommending Award of Contract and Approval**

WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, notifies the public of its resort to Alternative Method of Procurement through Negotiated Procurement after Two Failed Biddings, pursuant to Section V (D.3 (a.i) & (b.iv), Annex "H" of the Revised IRR of RA9184 for the procurement of the following civil works/infrastructure project described hereunder, with its corresponding Approved Budget for the Contract (ABC), under the reference, P.R. No. **2024-04-0309** || I.B. No. **2025-03 INF_NP** to wit:

WHEREAS, on 14 January 2025, by virtue of the same Notice to Bidders, the Bids and Awards Committee invited the following prospective bidders who were identified and listed under PAGASA's list of accredited contractors for infrastructure projects:

1. Kempal Construction and Supply Corporation
2. One Commerce (Int'l) Corporation
3. Massive Integrated Tech Solutions, Inc.

WHEREAS, in response to the BAC's invitation, one (1) participating bidder, **EGM Systems Global and Technologies, Inc.** expressed its intention to participate in the said bidding activity and attended the scheduled **Pre-negotiation conference** conducted by the PBAC on **23 January 2025**;

WHEREAS, one (1) prospective bidder, **M.C. Taguba Construction** also expressed its intention to participate in the bidding activities thereof by purchasing the required bidding documents;

WHEREAS, on **04 February 2025**, the scheduled **Submission, Receipt and Opening** of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), only one prospective bidder, **M.C. Taguba Construction**, timely submitted its bid tender documents for the project and passed the preliminary evaluation of bids;

WHEREAS, in the subsequent opening of Envelope No. II, the bidder's financial proposal has been accepted by the PAGASA-BAC having complied with the financial requirements of the Projects; Their respective financial proposals, "**as Read**", is summarized as follows:

WHEREAS, upon careful examination, validation and verification of the bidder's tender documents, including the evaluation report submitted by the TWG, the PAGASA-BAC determined that, **M.C. Taguba Construction** has complied accordingly on all the criteria for post-qualification and was responsive on all requirements and conditions specified in the Bidding Documents, Hence, it was moved and duly seconded that the **M.C. Taguba Construction** be declared as the **Single Calculated and Responsive Bidder (SCRB)** for the Project;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:


- a) to **DECLARE, M.C. Taguba Construction** as the Bidder with the Single Calculated and Responsive Bid (SCRB) for the Project entitled, *Installation of Electric Service Feeder Line and Electric Service Entrance Post in SL PRSD Building, Legaspi City, Albay – Negotiated Procurement*;
- b) to **RECOMMEND**, the award of the Contract to **M.C. Taguba Construction**, in the total calculated amount of *One Million Seven Hundred Eighty-Three Thousand Five Hundred Two Pesos & 95/100 (Php1,783,502.95) only*, for the implementation of Project; and
- c) to **RECOMMEND**, finally, the **APPROVAL** of the foregoing findings and recommendations.
