**Resolution Declaring 1st Failure of Bidding;
and Recommending Approval**

WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the MGEPS and PAGASA Bulletin board continuously for 7 days from **19 to 26 February 2025**, the procurement of the following goods/items described hereunder, with its corresponding Approved Budget for the Contract (ABC), under the reference, **P.R. No. 2024-11-0763 EPA || I.B. No. 2025-10** to wit:

- a) to **DECLARE**, the **1st failure of bidding** for the *Supply, Delivery, Installation, Testing, Commissioning and Training for the Establishment of an Integrated Hydrological Data Management System (HDMS) – Phase III*;
- b) to **RECOMMEND**, the mandatory review and evaluation of the terms, conditions and specifications in the Bidding Documents, including its cost estimates pursuant to Section 64.2 of the IRR of NGPA 12009; and
- c) to **RECOMMEND**, finally, the **APPROVAL** of the foregoing findings and recommendations.
