WHEREAS, in response to the above advertisement, four (4) prospective bidder/s, namely: (1) Nex Gen Tech Global Technologies (Philippines) Inc., (2) Tekzone Computer Sales and Services Inc., (3) AvTech Information Technology Solutions Inc., and (4) Quanby Solutions Inc. expressed their intentions to participate in the bidding of the aforesaid Project, on the scheduled Pre-bid conference conducted by the PBAC on 06 May 2025;

WHEREAS, any and all noted amendments and deviations discussed during the above-mentioned Pre-bid conference, have been duly issued through a **Supplemental Bid Bulletin** (SBB), with reference to **Addendum No. 2025-18-01** dated 09 May 2025 is herein made part of this Resolution as **Annex** "A";

WHEREAS, on 27 May 2025, the scheduled Submission, Receipt and Opening of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), only, World Solution Technology Inc., timely submitted its bid tender documents for the project and passed the preliminary examination of bids;

WHEREAS, in the subsequent opening of Envelope II (Financial Component), the lone bidder's financial proposal has been accepted for not exceeding the ABC. It's financial proposal as "Read", is as follows:

WHEREAS, on 10 June 2025, in a meeting conducted by the PBAC, it was duly noted that no request for reconsideration had been filed by World Solution Technology Inc., and that the prescribed period for filing such a motion had already expired.
