Resolution No. 2025-028

**Declaring Single Calculated and Responsive Bid (SCRB); and,
Recommending Award of Contract and Approval**

WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the MGEPS and PAGASA Bulletin board continuously for 7 days from **28 April to 05 May 2025**, the procurement of the following civil works/infrastructure project described hereunder, with its corresponding Approved Budget for the Contract (ABC), under the reference, **P.R. 2025-02-0099 | I.B. No. 2025-16 INF R** to wit:

WHEREAS, in response to the above advertisement, **five (5)** prospective bidders namely; (1) **Jessie Construction Services**, (2) **Vastcon Asia Construction Inc.**, (3) **Foreau Builders/MALTG Construction**, (4) **TFC Construction** and (5) **Jayterkiel Builders** expressed their intention to participate in the bidding of the aforesaid Project, on the scheduled **Pre-bid conference** conducted by the PBAC on **06 May 2025**;

WHEREAS, **one (1) prospective bidder**, (6) **Bancal Construction and Supply**, expressed its intention to participate in the bidding activities thereof by purchasing the required bidding documents;

WHEREAS, any and all noted amendments and deviations discussed during the above-mentioned Pre-bid conference, have been duly issued through a Supplemental Bid Bulletin (SBB), with reference to Addendum No. 2025-16-01 INF R dated 08 May 2025 is herein made part of this Resolution as **Annex “A”**;

WHEREAS, on **27 May 2025**, the scheduled **Submission, Receipt and Opening** of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), **only, Bancal Construction and Supply** timely submitted its bid tender documents for the project and passed the preliminary examination of bids;

WHEREAS, in the subsequent opening of Envelope No. II (Financial Component), the lone bidder financial proposal has been accepted for not exceeding the ABC. Its financial proposal, as **“Read”**, is as follows:

WHEREAS, the report on the detailed evaluation of bids conducted by the TWG resulted in the following: (a *copy of the report of TWG is hereto attached marked as **Annex “B”***)

WHEREAS, upon careful examination, validation and verification of the lone bidder tender documents, including the evaluation report submitted by the TWG, the PAGASA-BAC determined that, **Bancal Construction and Supply** has complied accordingly with all the criteria for post-qualification and was responsive to all requirements and conditions specified in the Bidding Documents. Hence, it was moved and duly seconded that **Bancal Construction and Supply** be declared as the **Single Calculated and Responsive Bidder (SCRB)** for the Project.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) to **DECLARE, Bancal Construction and Supply** as the bidder with the **Single Calculated and Responsive Bid (SCRB)** for the Project entitled, *Repair/Rehabilitation of PAGASA Transient Building – Re bid*;
- b) to **RECOMMEND**, the award of the contract to **Bancal Construction and Supply** in the total calculated amount of **Four Million Seven Hundred Forty-Seven Thousand Seven Hundred Sixty Pesos & 99/100** (Php4,747,760.99) only for the implementation of the Project; and
- c) to **RECOMMEND** finally, the **APPROVAL** of the foregoing findings and recommendations.
