WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the G-EPS and PAGASA Bulletin board continuously for 7 days from 15 to 22 October 2020, the procurement of the following civil works described hereunder, with its corresponding Approved Budget for the Contract (ABC), under the reference, P.R. No. 2020-08-0362/ I.B. No. 2020-002inf, to wit:

- a) to DECLARE, a Failure of Bidding for the above-entitled Project;
- to **RECOMMEND** the mandatory review and evaluation of terms, conditions and specifications of the project, pursuant to Section 35 of the IRR of RA 9184; and the immediate **re-posting** thereof for re-bidding purposes; and

 to RECOMMEND, finally, the APPROVAL of aforementioned finding and recommendations.
