WHEREAS, on 02 December 2020, the schedule for submission and opening of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), the above-mentioned prospective bidders timely submitted their bid tenders for the projects; However, none of them passed the preliminary evaluation of bids due to failure to comply with the simple instructions to bidders;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) to **DECLARE**, a 1st Failure of Bidding for the above-entitled Project;
- to **RECOMMEND** the mandatory review and evaluation of terms, conditions and specifications of the project, pursuant to Section 35 of the IRR of RA 9184; and the immediate **re-posting** thereof for re-bidding purposes; and
