**Resolution Declaring as Single Calculated Responsive Bid;
 Recommending Acceptance of the Lowest Price Quotation; and
 Recommending Approval**

WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, posted the Notice to Bidders on **04 July 2022** at the PAGASA website and PAGASA Bulletin Board, notifying the public of its resort to alternative method of procurement through **Negotiated Procurement after Two Failed Biddings**, pursuant to *Section V (D.3 (a.i) & (b.iv)), Annex "H" of the Revised IRR of RA9184*, the procurement of the following goods/items described hereunder, with its corresponding Approved Budget for the Contract (ABC), under the reference, **P.R. No. 2021-10-0005 EPA / NB. No. 2022-008 NP**, to wit:

WHEREAS, in response to the said invitation, **three (3)** prospective bidders, expressed their intention to participate in the said bidding activity and attended the **Pre-negotiation Conference** scheduled by the Bids and Awards Committee on **13 July 2022**, namely:

WHEREAS, any and all noted deviations/amendments appurtenant to the Project has been issued through a **Supplemental Bid/Bulletin (SBB)**, with reference to **Addendum No. 2022-008-01** dated 21 July 2022, herein made part of this Resolution as **Annex "A"**;

WHEREAS, on **01 August 2022**, the amended schedule for the **Submission, Receipt and Opening** of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), **Sanderland Corporation**, the lone bidder **timely** submitted its tender documents for the project and passed the preliminary evaluation of bids;

WHEREAS, upon notification and presentation of the lone bidder of the BAC's detailed calculation of bids and notifications to submit the requisite "post-qualification documents, the Sanderland Corporation, readily conformed thereto and timely submitted the required post-qualification documents;

WHEREAS, on **30 August 2022**, during the BAC's discussion, it has been manifested and unanimously agreed by the members that the TWG must conduct background investigation on the declared completed contracts of the participating bidder;

WHEREAS, on **19 September 2022**, upon careful examination, validation and verification of **Sanderland Corporation**, tender documents, including the evaluation report submitted by the TWG, the PAGASA-BAC determined that, the **lone bidder** has complied accordingly on all the criteria for post-qualification and was responsive on all requirements and conditions specified in the Bidding Documents. Hence, it was moved and duly seconded that the **Sanderland Corporation** be declared as the bidder with the **Single Calculated and Responsive Bid (SCRB)** for the implementation of the project.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**: To

- a) **DECLARE, SANDERLAND CORPORATION**, as the Bidder with the **Single Calculated and Responsive Bid (SCRB)** for the Project, entitled, "*Supply, Delivery and Installation of Various ICT Equipment and other Components of Data Rescue and Digitization of Climatological and Agrometeorological Archive*" in the total calculated amount of **One Million Eight Hundred Seventy-One Thousand Forty-Four Pesos Only (Php1,871,044.00) Only**;

- c) **RECOMMEND**, finally, the **APPROVAL** of the foregoing findings and recommendations.
