Resolution Declaring as SCRB Recommending Award of Contract and Approval

WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the MGEPS and PAGASA Bulletin board continuously for 5 days from 27 April to 04 May 2022, the procurement of the following goods/items described hereunder, with its corresponding Approved Budget for the Contract (ABC), under the reference, P.R. No. 2022-03-0263 / I.B. No. 2022-014, to wit:

WHEREAS, the provision of R.A 9184 and its Revised Implementing Rules and Regulations (IRR), other pertinent guidelines and procedures relative to government procurement system are hereby observed and strictly implemented for the whole duration of this bidding activity;

WHEREAS, in response to the above advertisement, only one (1) prospective bidder, STATE ALLIANCE ENTERPRISES, INC., expressed its intention to participate in the said bidding activity and attended the Pre-bid conference on 16 May 2022 scheduled for this purpose;

WHEREAS, any and all noted deviations/amendments appurtenant to the Project has been issued through a Supplemental Bid/Bulletin (SBB), with reference to Addendum No. 2022-014-01 dated 04 May 2022 and Addendum No. 2022-014-02 dated 19 May 2022 and herein made part of this Resolution as Annex "A" and Annex "B";

WHEREAS, on 30 May 2022, the schedule for Submission, Receipt and Opening of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), the lone bidder timely submitted its tender documents for the project and passed the preliminary examination of bids;

WHEREAS, the lone bidder's financial proposal has been accepted for not exceeding the ABC. Its bid tender, "as Read", is as follows:

WHEREAS, upon careful examination, validation and verification of STATE ALLIANCE ENTERPRISES, INC.'s tender documents, including the evaluation report submitted by the TWG, the PAGASA-BAC determined that the latter has complied accordingly on all the criteria for postqualification and was responsive on all requirements and conditions specified in the Bidding Documents.

Hence, it was moved and duly seconded that the STATE ALLIANCE ENTERPRISES, INC., be declared as the bidder with the Single Calculated and Responsive Bid (SCRB) for the Project.
