



**PAGASA BIDS AND AWARDS COMMITTEE (PBAC)**

**Resolution Declaring Single Calculated Responsive Bid (SCRB)  
and Recommending Award and Approval**

**Resolution No. 2022-002**

**WHEREAS**, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the G-EPS and PAGASA Bulletin board continuously for 7 days from **10-17 November 2021** the procurement of the following goods/items described hereunder, with its corresponding Approved Budget for the Contract (ABC), under **PR No. 2021-08-0567 and ITB 2021-054**, to wit:

**WHEREAS**, the provision of R.A. 9184 and its Revised Implementing Rules and Regulations (IRR), other pertinent guidelines and procedures relative to government procurement system are hereby observed and strictly implemented for the whole duration of this bidding activity;

**WHEREAS**, in response to the said invitation, three (3) prospective bidders, namely: (1) **Licht Industrial Corporation**; (2) **MVA Power Systems Development Corporation**; and, (3) **Inframachineries Corporation**, expressed their intention to participate in the bidding of the aforesaid Project, and attended the **Pre-Bid Conference** conducted by the PAGASA-BAC on **18 November 2021**;

**WHEREAS**, all noted deviations and/or amendments including the BAC's answer and the clarificatory letter/s submitted by the prospective bidder attendant to the Project as discussed and agreed upon in the above-mentioned meeting was issued through a **Supplemental Bid/Bulletin (SBB)** with reference to **Addendum No. 2021-054-01**, dated **22 November 2021**, herein made part of this Resolution as Annex "A";

**WHEREAS**, on **01 December 2021**, the schedule for submission and opening of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), only **Licht Industrial Corporation** timely submitted their bid tenders for the Project and passed the preliminary examination of bids;

**WHEREAS**, in the subsequent opening of Envelope II (Financial Component), the **lone bidder's** financial proposal has been accepted for not exceeding the ABC. Its bid tender, "as Read", is as follows:

**WHEREAS**, upon careful examination, validation and verification of **Licht Industrial Corporation** tender documents including the evaluation report submitted by the TWG, the PAGASA-BAC determined that the **bidder** has complied on all the criteria for post-qualification and has been responsive on all requirements and conditions specified in the Bidding Documents. Hence, it was moved and duly seconded that **Licht Industrial Corporation** be declared as the bidder with the **Single Calculated and Responsive Bid (SCRB)** for the implementation of the instant Project.


