Resolution Declaring 1st Failure of Bidding; and Recommending Approval

Resolution No. 2022-015

WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the G-EPS and PAGASA Bulletin board continuously for 7 days from **08 to 15 February 2022**, the procurement of the following goods/items described hereunder, with its corresponding Approved Budget for the Contract (ABC), under the reference, P.R. No. 2022-01-0005/ I.B. No. 2022-004, to wit:

WHEREAS, in response to the said advertisement, three prospective bidder/s namely: 1) QUARTZ BUSINESS PRODUCTS; 2) AVID SALES CORPORATION and 3) TERABIT COMPUTER SYSTEMS CORPORATION, expressed its intention to participate in the bidding. However, Terabit Computer Systems Corporation did not attend the Pre-Bid Conference conducted by the PAGASA-BAC on 16 February 2022;

WHEREAS, on 28 February 2022 the schedule for Submission and Opening of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), the Terabit Computer Systems Corporation timely submitted their bid tenders for the projects; However, they did not pass the preliminary evaluation of bids due to failure to comply with the simple instructions to bidders;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED:**

- a) to DECLARE, a Failure of Bidding for the above-entitled Project;
- to RECOMMEND the mandatory review and evaluation of terms, conditions and specifications of the project, pursuant to Section 35 of the IRR of RA 9184; and the immediate re-posting thereof for re-bidding purposes; and
- c) to **RECOMMEND**, finally, the **APPROVAL** of aforementioned finding and recommendations.
