**Resolution Declaring 2nd Failure of Bidding;
 Recommending Resort to Alternative Method of Procurement thru
 Negotiated Procurement – Two-Failed Biddings; and
 Recommending Approval**

WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website and PAGASA Bulletin board continuously for 7 days from **23-30 June 2022**, the procurement of the following civil works described hereunder, with its corresponding Approved Budget for the Contract (ABC), under the reference, **P.R. No. 2022-04-0305/ I.B. No. 2022-001INF – Re bid**, to wit:

WHEREAS, in response to the above advertisement, **two (2) prospective bidders** expressed their intention to participate in the bidding of the aforesaid Project and attended the **Pre-bid Conference** conducted by the PBAC on **1 July 2022**, namely:

1. **High Beam Construction**
2. **Blaff Construction and Supplies**

WHEREAS, **two (2) other prospective bidders**, namely: (3) **Hachi Construction Services** and (4) **Malagueña Construction**, also expressed their intentions to participate in the bidding activities thereof by purchasing the required bidding documents;

WHEREAS, any and all noted amendments and deviations discussed during the above-mentioned Pre-bid conference, has been duly issued through a **Supplemental Bid Bulletin (SBB)**, with reference to **Addendum No. 2022-001INF-01** dated 27 June 2022 and **Addendum No. 2022-001INF-02** dated 04 July 2022 and herein made part of this Resolution as **Annexes “A” and “B”** respectively;

WHEREAS, on **13 July 2022**, the schedule for **Submission and Opening** of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), **only Malagueña Construction**, timely submitted its tender documents for the Project; however, failed to pass the preliminary evaluation of bids due to **failure to comply with simple Instructions to Bidder**, more specifically, *“failure to submit Copy of the company’s updated PCAB license; and, failure to comply with the additional instruction to bidders under “Class A documents,”* which are grounds for outright rejection of bids and disqualification of the bidder.

WHEREAS, in view of the foregoing, the PBAC declared the 2nd failure of bidding for the above-entitled Project;
