



PAGASA BIDS AND AWARDS COMMITTEE (PBAC)

Resolution No. 2023-030

Declaring 1st Failure of Bidding; and Recommending Approval

WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the MGEPS and PAGASA Bulletin board continuously for 7 days from **19 to 26 May 2023**, the procurement of the following goods/items described hereunder, with its corresponding Approved Budget for the Contract (ABC), under the reference, **P.R. No. 2023-02-0090 / I.B. No. 2023-004** to wit:

WHEREAS, in response to the above advertisement, **five (5) prospective bidders** namely: 1) **BP Integrated Technologies, Inc.**; 2) **Electrobyte Environment Concerns Corporation**; 3) **Massive Integrated Tech Solutions, Inc.**; 4) **Sunshine Multi Plus Corporation**, and 5) **Domestic Trading Corporation**, expressed their intention to participate in the bidding of the aforesaid Project, on the scheduled **Pre-bid conference** conducted by the PBAC on **29 May 2023**;

WHEREAS, any and all noted amendments and deviations discussed during the above-mentioned Pre-bid conference, has been duly issued through a **Supplemental Bid Bulletin (SBB)**, with reference to **Addendum No. 2023-004-01** dated 02 June 2023 and **Addendum No. 2023-004-02** dated 06 June 2023 are herein made part of this Resolution as **Annex "A" and Annex "B"** respectively;

WHEREAS, on **26 June 2023**, the schedule for **Submission, Receipt and Opening** of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), **only two (2) participating bidders** namely; 1) **Electrobyte Environment Concerns Corporation**, and 2) **BP Integrated Technologies, Inc.** timely submitted their bid tender documents for the Project; ; however, **Electrobyte Environment Concerns Corporation** has been declared by the PAGASA-BAC as "Disqualified" due to **failure to comply with the submission of Technical and Financial requirements**, more specifically, *failure to submit a valid Tax Certificate*;

WHEREAS, in the subsequent opening of Envelope No. II, the remaining bidder's financial proposal has been accepted by the PAGASA-BAC having complied with the financial requirements of the Project; The **BP Integrated Technologies, Inc.** bid tender, "**as Read**", is summarized as follows:

WHEREAS, on **26 June 2023**, the PBAC Secretariat received the Request (Motion) for Reconsideration from bidder Electrobyte Environmental Concerns Corporation and after due deliberation it has determined that there is no substantial reason to depart from the earlier decision to disqualify the bidder. WHEREAS, on **03 July 2023**, the report on the detailed evaluation of bids conducted by the TWG, resulted the **non-compliance** of **BP Integrated Technologies, Inc.** A copy of the report of TWG is hereto attached marked as **Annex "D"**;

WHEREAS, on **04 July 2023**, the PBAC issued a Notice of Disqualification to participating bidder BP Integrated Technologies, Inc. Copy of the Notice of Disqualification is hereto attached marked as **Annex "E"**;
