**Declaring Single Calculated and Responsive Bid (SCRB);
 Recommending Award of Contract and Approval**

WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the MGEPS and PAGASA Bulletin board continuously for 7 days from **21 to 28 June 2023**, the procurement of the following goods/items described hereunder, with its corresponding Approved Budget for the Contract (ABC), under the reference, **P.R. No. 2023-06-0359 / I.B. No. 2023-006** to wit:

WHEREAS, on **11 July 2023**, the schedule for **Submission, Receipt and Opening** of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), **American Technologies, Inc.** timely submitted their bid tenders for the project and passed the preliminary examination of bids;

WHEREAS, in the subsequent opening of Envelope No. II, the bidder's financial proposal has been accepted by the PAGASA-BAC having complied with the financial requirements of the Projects; Their respective financial proposals, "**as Read**", is summarized as follows:

- a) to **DECLARE, American Technologies, Inc.** as the Bidder with the Single Calculated and Responsive Bid (SCRB) for the Project entitled, "*Supply and Delivery of Ten (10) units of High Frequency Single Sideband (SSB) Radiophone;*";
